

Harstad Park - Located on the Eau Claire River between the cities of Fall Creek and Augusta on CTY HHH. Harstad Park is for those who enjoy the quietness of nature. There is no electricity or running water in this park. There are park/picnic facilities and a campground. Park/picnic facilities are open to the public daily until 11:00 pm. The camping season runs May 15 through September 15. Off-season camping fees are charged from September 16 through May 14 (see fee schedule for rates).

The Campground - There are 27 campsites in the park for use by registered campers and their guests. Each campsite has a picnic table, bench, and fire ring. All fires are to be kept within the fire ring. A water pump, two pit toilets, and firewood lot are located within the campground area. There are nightly and weekly camping rates (see fee schedule for rates). The maximum length of stay on a campsite is fourteen nights.

Registration - This is a self-registering campground. Registration forms and instructions are located near the entrance of the campground. Registration must be completed within 30 minutes of occupying a campsite.

Vehicles - No more than one recreational unit may occupy a campsite. Motor vehicles must be parked on the gravel parking area of the campsite. No more than two vehicles, which includes the camping unit if a vehicle, are permitted at any one campsite. Visitors must use the parking lot located near the large picnic shelter in the day park area if there are already two vehicles at the campsite. No vehicle can be left in the parking lot after 11:00 pm.

Firewood - Is available from the park attendant and is sold at the shelter near the drinking water (see fee schedule for rates). It is unlawful to disturb, damage, deface, remove, vandalize, or destroy any trees, shrubs, plants, or other natural growth within the parks or surrounding area.

Pets - Pets must be kept on a leash no longer than eight feet and must be under the owner's control at all times. Please fill in any holes dug up by your pets and clean up any droppings. Pets are not allowed on the playground or the picnic area. Pet owners are expected to keep their pets quiet during the quiet hours.

Quiet Hours - Are between 11:00 pm and 6:00 am. Other than registered campers, all visitors must leave the park before 11:00 pm and no persons or vehicles, other than registered campers, will be allowed to enter the park during quiet hours, except in the case of an emergency. Noise from one campsite should not be bothersome to other campers in the park. Those interested in "burning the midnight oil" are asked to speak softly, turn radios off or play them at a low volume, and not make unnecessary noise.

Garbage/Recycling - All trash and garbage must be put into the park dumpsters. Do not place or burn trash or garbage in the fire rings. Eau Claire County recycles: please assist us by bringing your recyclables to the recycling bins located near the firewood lot.

The Day Side - Located north of the campground overlooking the Eau Claire River is available to all campers and park visitors. Facilities include: a canoe landing; pit toilets; water pump; playground; picnic tables; grills; picnic shelter; and ball diamond.

The Picnic Shelter - The county's largest picnic shelter is reservable for family or business gatherings. The shelter has eighteen picnic tables with a seating capacity of approximately 125 people. There are charcoal grills located near the shelter. Contact the Parks and Forest Department at 715-839-4738 for current rate and to reserve the shelter.

Other Regulations - It is unlawful to possess, discharge, explode, or set off any explosive or pyrotechnic device containing powder or explosive material within Harstad Park. This includes most kinds of fireworks. Weapons of all kinds, including bows, arrows, and slingshots are prohibited unless unloaded and enclosed in a carrying case. The speed within Harstad Park is 10 miles per hour. All roads within the campground area are one-way. This also applies to bicycles. Park rules and regulations are for your safety and enforced by park staff and the Eau Claire County Sheriff's Department.

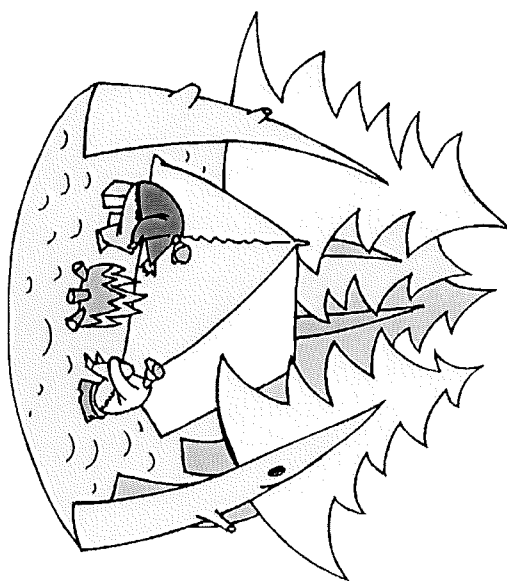

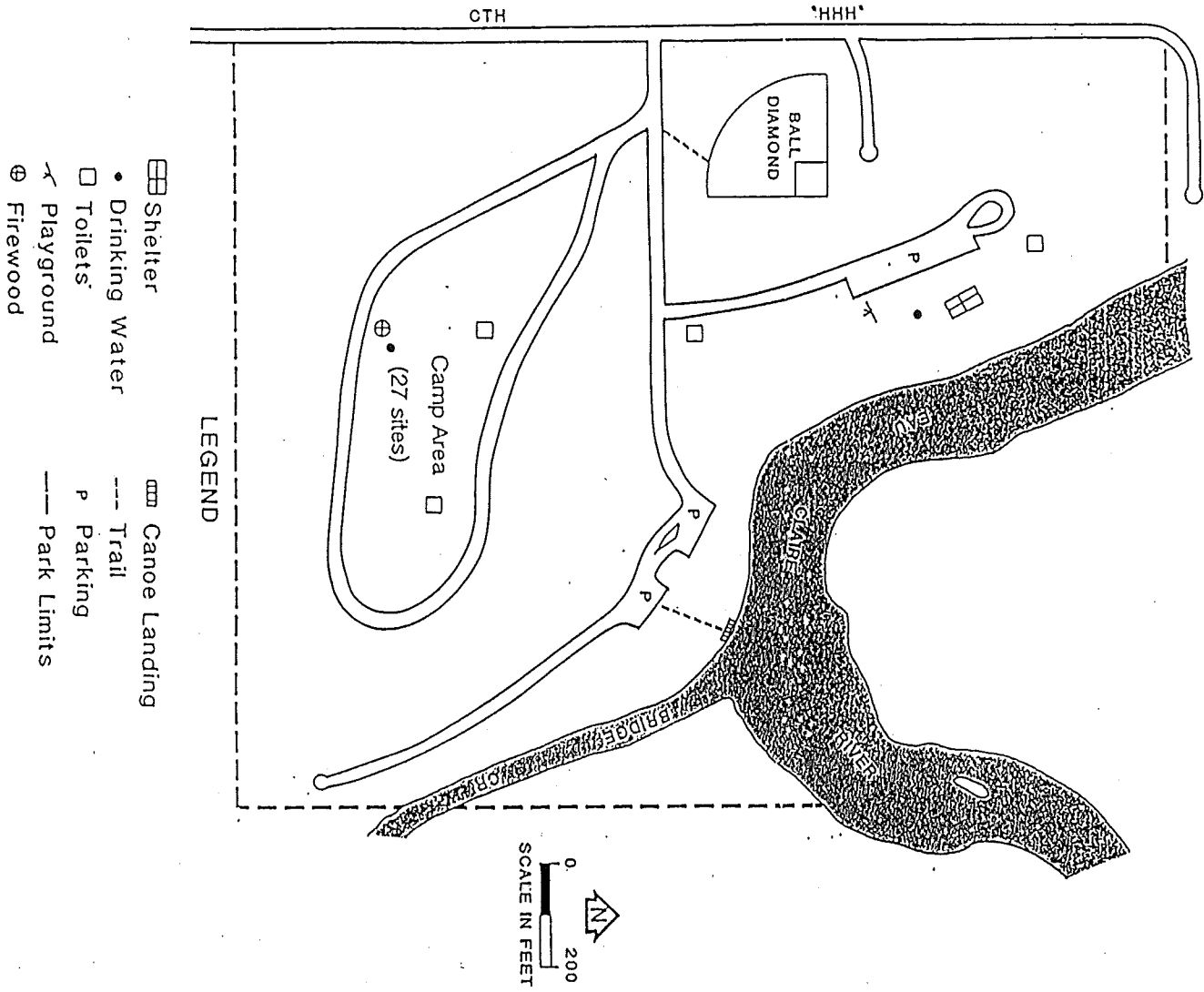
